



## The 7th PERSILAT Congress Jakarta, December 16, 2010

On behalf of The Indonesian Pencak Silat Association - Ikatan Pencak Silat Indonesia (IPSI) allow me to welcome the Minister of Sports and Youth of Indonesia representing the President of the Republic of Indonesia to the Opening of Congress of PERSILAT which is being held here in Jakarta. This is high tight of pencak silat internationally and we are very optimistic that in the coming years more and more participants will be coming.

The problems of pencak silat is of course in the promotion of pencak silat. As we are all know, first of all is the difficulty in gaining financial support because the training of referees, instructors, jurors, all need concentration and needs finance.

In the coming years we must get more sponsorship, more corporate backing and also more helping from governments of the originators of PERSILAT Indonesia, Malaysia, Brunei and Singapore. That is the challenge of PERSILAT to gain more financial support that we can enlarge the professional and the athletics professionalism and performance of pencak silat that can be attractive to the young generation of the whole world.

I would like to report to your excellency also that they are already 4 Governor of Provinces who have approached us and thinking their willingness to support this event. They are Governor of Bali, East Kalimantan and Riau who are very enthustiastic in trying to host this next venue.



#### Plenary Session I

A. Report on PERSILAT Activities



Mr. Eddie M. Nalapraya reported activities of PERSILAT since 2004 until 2010 chronologically using overhead presentation. Report covers founders meetings, central board meetings, pencak silat championships, single events (world pencak silat championships, pencak silat open), multi events (SEA Games, University Games, Beach Games), exhibitions, training local as well international, conduct referee-jury courses, seminars, and appreciations. The report was unanimously accepted by the Congress.

#### Plenary Session I **B. Report from Country Members**



Chairman: "We now go to the next point of the sessions which are reports, suggestions, recommendations and discussions from all countries. I propose that we start from Malaysia, because I am still chairing this Congress. May be I later will give the leadership of the meeting to another Chairman of IPSI. We start from Malaysia and continue down the table to Vietnam, Philippines, UK and so forth. I would like to give the floor to the distinguished representative from Malaysia to provide general explanation, report of pencak silat and recommendation and comments for the future. Please, Sir."

Malaysia: "Thank you Mr. Chairman. Dear President Bapak Eddie Marzuki Nalapraya, Dear Vice Presidents, ladies and gentlemen. Malaysia would like to report that last year we have new election of President. The new President now is YAB Dato Seri Haji Mohd. Ali bin Mohmd. Rustam as a new President of PESAKA. Hopefully he can serve around 10 years. There is announcement from the State Government of Melaka that by year end of 2011 we will have the biggest arena of pencak silat in the world supported by State Government of Melaka and Federal Government of Malaysia. This arena requires about 25 million ringgit involvement of money which has been spent. Hopefully by having the biggest arena for pencak silat it will be more promoting pencak silat in Malaysia. Obviously we will also need help of PERSILAT in order to enhance the mixed silat as one of the most popular sport and culture in the next future to come. At the same time PESAKA are ready at anytime to organize any meeting or championship. The new President is very committed person in bringing silat to Malaysia."

Philippines: "In the Philippines pencak silat is growing bigger especially in the 2 big islands Pesaya and Mindanao which is Moslem dominated area. And we are now have the pencak silat goes to school program where at every school we have demonstration of pencak silat. Not only that, we have also out of school program for pencak silat. We are trying to promote pencak silat as a mass basis sport that we like to include the out of school program. And we have developed pencak silat so much for generations. Yearly we have martial art sport championship in order to choose the best

of the best in Philippines of pencak silat. Year 2008, 2009 until the middle of 2010 was the good years for pencak silat since political struggle."

United Kingdom: "The national championships in UK was a great success consists of 9 countries taken part. The opening was attended by the Director of Sport Government Department Culture and Sports and receive media coverage in UK and in Indonesia. On national activities we have now large perguruans in UK including Merpati Putih, Cimande, Silat Kuntau Macan and Mustika Kita. Youth development program continues to be very successful PESILAT co ass is being taken part in school to help developed the Youth for future generation to include. The most attendance in junior championship were Belgium and Paris were very well. With help of PERSILAT a great number of youth take training for several month in Indonesia in Padepokan in 2008. We also hope to send it again in the future to develop and wasit juri. For the future we would like to improve youth development program and have gold medal from world championship. We have 5 years strategy to develop school of persilat. We also would like to implement

Uzbekistan: "Our federation is the only one in Central Asia on pencak silat and we will try to involve neighbor countries like Kazakhstan, Kirzygistan, Tazikistan, Turkmenistan to the international federation of pencak silat."

Azerbaijan: "The states is the main promoter of pencak silat. Therefore pencak silat is being developed in Azerbaijan on the highest level. It is my personal opinion that for the better and stronger development of pencak silat, the countries who are the primary development of pencak silat need to be strong and need to be supported by the government. At the end I would like to personally thank Mr Eddie Nalapraya because he had done great work on his own. At the end I would like also to suggest that the annual activities commander is playing in the internet or send to the participants to allow for preparation the championship in time. I would like to thank you for your attention."

Russia: "Now in Russia pencak silat is official sport and we do everything that pencak silat is become more and more popular. Now we have more than 300 hundred athletes. Pencak silat is supported by the Federal Government. We hope soon we can awake all country open pencak silat. Thank you, terima kasih."

Switzerland: "Dear President of PERSILAT, report from Switzerland, a small country, since last period from 2004 until we had 3 Swiss Open, we were host for European Championship in 2008 and at the moment we are concentrating working on the youth for the next generation of pencak silat. And also for event in the future we are planning to have something like cup system something like Euro Cup. We work together with all schools also with business schools so that we can work together among friends and develop silat in more advances in the future. I would thank you also to the OC for this championship and t hank you for the congress we have here hope we can proceed with good and in friendly way and things that happen in this tournament won't happen again in the future. Thank you."

Japan: "Bissmillahir rohmanir rohim. Ass wr wb. First of all thank you to Pak Eddie Nalapraya and Pak Prabowo Subianto for all support for this congress. I want to report what we have done from 2004 to 2010. Almost every year we send athlete to Europe since 2004 under Singapore world championship because we could not have any competition inside our country so we need to find some tournament otherwise we send our athlete mostly to Europe. This is the first time since we establish in 1996 we could not send team to world championship. I am very sad to say that Announcement for this championship is too short. We could not prepare in 4 months. First, we know the championship start of this year but then postpone to "someday". So most of our athletes already used their holiday and budget to another championships. That is why we could not send our athletes to this big event. For international event we could not send our athletes to South East Asia but for region things we can send to Asian Martial Arts Games and Asian Indoor Games in 2009. Because our organization is not so big we could not get official license from National Committee in Japan. Even though we are member of Japan Martial Arts Sport Federation. This federation is officialized by Japan Oliympic Committee but we could not send for Asia Indoor. When I heard invitation for Asia Indoors, Japan Olympic Committee refused us because we are too small but Director of Japan Martial Arts Federation recommended us to get recommendation letter from PERSILAT. I made a phone call, email to PERSILAT but all of you were very busy with Asia Martial Arts in Thailand. So we missed Asia Indoor also. Anyway, this is big sad that we could not send team to this big event. Thank you very much."



Germany: "We have nothing to report at this time. Thank you."

The Netherlands: "Mr. Chairman, thank you for organizing this PERSILAT Congress and world championships. Thank you the President of PERSILAT Bapak Eddie Nalapraya and all President from Founding Members. Hello to my fellows Presidents. Thank you for your attention. I like to use this opportunity not to report about the development or activities of pencak silat in the Netherlands or in Europe but I would like to share my vision with you pertaining the future of PERSILAT. Some of you already could reach what I have been sending thru by emails in the last 2-3 years. In the future PERSILAT has to fulfill its mission to get pencak silat be recognized by IOC - International Olympic Committee. The main step we have to take is to reform or remodel the organization structure of PERSILAT. In order to get recognize the status practice and activity of PERSILAT must be in conformity with Olympic Charter that means that we have to reform or remodel the organizational structure of PERSILAT in view of the requirement of the IOC. To fulfill the requirement of the IOC one thing that has to be done is to start sort of democratization process with first in my opinion one most important step is more influence for all of the members of PERSILAT by giving each of them the right to vote for presidency and to have a contestant presidential election. Of course PERSILAT maintains the independence and autonomy but has to follow the democratic procedures and extending the form of social decision making. So let them all the member countries are included in the process of decision making. In my opinion the Founding Members should get the right of veto for technical and artistical issues, of course, to guarantee the purity of pencak silat and to preserve the prestigious inheritance of the Indonesian and Malayan community. I propose this meeting of PERSILAT to get a kind of transitional period in which committee can be appointed to oversee the reorganization of PERSILAT. I would like to suggest this meeting and to propose to PERSILAT to the incumbent President of PERSILAT Bapak Eddie Nalapraya to direct the process of reformation and reorganization of PERSILAT. And that should be the most important goal for the next term having good and well prepared Congress with candidate we all know for next term to reach and get direction to reorganization of PERSILAT. That is my proposal 1 would like to suggest to this meeting and Board of PERSILAT. I sugges to add fifth category of festival to competition: 1-tanding, 2-tunggal, 3-ganda, 4-regu and 5-festival. Last suggestion is to announce where the next championship will be held. Thank you very much."



Thuiland: "Good afternoon. I am proud to say silat at that everything is in peace. Keep in touch. Thank you.

Brunei: "Ass wr wb. Respected Chairman, respected Mr. Eddie Nalapraya President of PERSILAT, Brunei Darussalam PERSIB is a martial art organization that are superior in Brunei Darussalam. First, the appointment of 4 years overall PERSIB committee. Second, according to PERSIB law, registration of Brunei Darussalam, PERSIB a martial art is under the control of federal registration of the country and blessed by the Ministry of Culture and Sports PERSIB there. Third, join the Olympic Councel PERSIB country Brunei Darussalam. PERSIB each year carry out silat championship. The first martial art was in the original pure martial art called Catak Brunei Darussalam Brunei and Kunta. Second, perform martial art competition sport, and the arts competition. PERSIB also often come to an invitation or an invitation competition martial art in the nation, and although there are things that can not be met because there is something about the business of martial art. PERSIB in the Brunei Darussalam National competition first, second, high school tournament in Brunei Darussalam, and the young martial arts competition. PERSIB God willing in the future after this congress we will make certain the program hopefully we will have a successful martial art is superior to the world and hopefully the program will be PERSIB further innovations. Thank you. Ass wr wb.

Singapore: "The only important thing that I would like to express today is we really would like to look into coordination, a well informed activities where all of us know of everything all the time. I feel that we are lacking in this stage we do not really know much about our friends. We are saying that we are related, we are friends, we know each other, we are family, but we do not know what is happening to the family of our neighbors. We really hope that PERSILAT would play very important role to link us together. Form an inspiring web that link us together. Now we have only 30-32. Should happen in one day we will have hundreds of us. How are we suppose to link each other if the main body did not do so. This is our main concern for the changes that we would like to see in the future of PERSILAT.

There is only 1 federation in Singapore. Even the government only accredited 1 federation. I really hope this to happen in some other country also. There is no double or duplication of such activities because it always create chaos to the unity. If the only one affiliated to PERSILAT then the work will go on well. I would like to request for the next term of PERSILAT for such report from all the countries all of us bring back consisting all report from all countries. May be we will be informed 1 or 2 months before the Congress to submit the report in the form. That is the best we can bring back to be presented to our youngsters, not flower or gift. That is the best way, besides posting in the website.

As my President says, we are looking forward to your support from all the countries for the event 2011 and 2012. We have traveled to more than 19 countries in Asia we really want this nearby friends to help us in include silat to the ASIA Games in 2014. I would like also to have PERSILAT concern to looking to warming up for this Asia federations and I would like to inform you all that Singapore is willing to hold responsibility to make sure that silat come to Asia Games 2014. We really need your support for this. Thank you very much.

INDONESIA: "IPSI has continued to maintain, develop and promote pencak silat in Indonesia.IPSI has 10 historical schools or perguruan that established IPSI in 1948 but 4 or 5 are nearly extinct and at least 1 perguruan that we can not find its address. The teachers, the masters have died and many of the students have not continued the activities. IPSI still recognizes them since some of them still send representative to our National Congress. IPSI has 6 (six) perguruan besar or big national schools which have been borned after 1948 but have developed into quite big schools with thousands of athletes. They are 1-Merpati Putih, 2-Kalimasada, 3-ASAD, 4-Satria Muda Indonesia, 5-PSTD, and 6-Pagar Nusa. Those are actually now quite prevalence in most of areas in Indonesia in national bases and therefore the 10 historical schools and the 6 national large schools are now basically the main drive of Pencak Silat in Indonesia. IPSI has hundreds and hundreds of perguruan, local and regional on their own developing, practicing, carrying out their aliran and their forms. 1. Support from Government. We have several very positive interested. We must now concentrate on gaining full government support and sponsorship plus financial backing by the 4 founding countries because this is where pencak silat originated. Therefore it is our moral and historical responsibility to gain the support of our various government in order that we can gain more financial sponsorship that we can achieve the hopes and the target that have been expressed by all the member of participants. I have talked to the representative of Malaysia, Brunei and Singapore we are at the same opinion that now we have to work harder and we will plan in the near future to visit the leaders of our various government. I have asked for appointment today to the Minister of Sports for him to arrange that we will be received by the President of Indonesia, the Minister of Education, the Minister of Finance and the Minister of Sports to get his promise that he will support us. We also plan to meet the Prime Minister of Malaysia. And I myself have a plan to meet him for another matter. Afterwards, I will have discussion about pencak silat. We will ask the

support from Brunei federation for us to call upon the Government of Brunei. Hopefully received by the Sultan of Brunei himself because Sultan is also Prime Minister. We would like to get the support from Authorities from Singapore. We accept fully this recommendation and have discussed even before your recommendation.

- 2. Shortcoming of Committees. There was also critics and correction and on behalf of the host I apologize with the shortcoming. Last night there were some incidents in the execution during the game. I take full responsibility and I apologize for this discourses and I hope this will not spill over into something more serious. We will overcome that. Also if there was a mistake from our committee who doesn't understand which way of the flag must be presented, I would like to apologize as the responsible chairman. I will call my subordinate in the committee and will give a bit of my opinion. This is very small but very sensitive. I also do not like to see my flag upside down because that is the flag of Poland and not Indonesia. I accept the critics.
- 3. Request for Training. IPSI has already plan next year to open clinics and workshops. The concern is that visa for more than 1 month. We have to negotiate with the government and I think this can be easily done. The clinic will be tailored to the requirement of many of the countries and we will open to all countries wishing to send for the clinics. We will announce several months ahead where and when it will be opened and how many slots we can allocate to each member of federation. We will provide at least 5 slots for each federation but if there are more request we will consider it. I have gotten already promises support from several governors that this activities can be sponsored and supported by them in the various reagents because they want to promote pencak silat also. We can help the countries and will take responsibility for the training, the food and the accommodation. With regard to the transport we will negotiate with the sponsors so that they can also sponsor the tickets. Now GARUDA INDONESIA has already opened flights back to Europe and to US after stopped due to 1998 crisis. Previously we can get sponsorship from GARUDA whereas for every 5 tickets we can get 1 free. This could support various federations.
- 4. Reform the Organization of PERSILAT. We should address very seriously the recommendation from The Netherlands to adjust or reform PERSILAT. I personally have not been involved in PERSILAT but I will refer this suggestion to the Founding Members. This is something that we should seriously consider. I personally support the reformation or remodeling that PERSILAT will become more democratic, more 'in tune' to adjust ourselves to the Olympic Committees. But also I remind all of us that in present development of pencak silat, the difference on the development of different countries must be taken into consideration. Also certain aspects of pencak silat requires certain handling or consideration. I do agree we must adjust with the time. We must have full participation from all the members. I will refer this to the Founding Members of PERSILAT. In this occasion, as Chair of the the congress, I summarize and the summary will be referred to the Founding Members. And after we adjourn for lunch we will re-continue and during the adjournment the Founding Members will have discussion on how we will address the recommendation.
- Next World Championships. Four countries have offered to voluntarily host the next world championships:
  - a. Saudi Arabia, the first country offering the host of next championship of 2012 or 2014
  - b. Suriname, the second country offering the host of 2012 or 2014
  - c. Malaysia, the third country offering the host of 2012 or 2014
  - d. Vietnam, the forth country offering the host of 2012 or 2014
- 6. Correction from IPSI. As the last member to give comment and suggestion in this Congress, I am as President of IPSI would like to give corrections to PERSILAT Organizing Committee on the

Agenda of an international congress. The Agenda now is to hear the opinions questions and recommendations from the participants and next the appointment or the election of the new president. However, in my opinion, during this opportunity for congress should be a session or sessions that the congress should be divided into committees and commissions to discuss the different aspects. First, how to reform or change the constitution, if will be. Two, how to change the program or programs, if need be. Three, how to improve technics, promotions, etc. This is my understanding. However, as I said, I am here just to carry out as the Chairman who has no authority on the Agenda. May be the consideration of Organizing Committee is time factor, or finance, or congress may be too long, etc. As of now, timing is not so bad, because even though the opening was delayed but we are not running too behind schedule. This is my correction.

#### CONCLUSION

All recommendation that we have been received today are very positive that PERSILAT will also accept the recommendations and the corrections. We will also convey the recommendations and corrections to whoever will be entrusted leading PERSILAT in the future.

Can be re-convinced at another time or we could do it now if the participating members decide to stay in Jakarta either tonight or to stay for few more days. Or we can also re-convince in 1 month time or 2 months time for this special working committee to carry out the remodeling or reform. I will support we should do

Plenary session II A. Appointment of President of PERSILAT



Decision of Founding Members announced by President of PESAKA, Malaysia: "Thank you for your cooperation and your opinion for our goodness.

Firstly, the founding members of PERSILAT as the highest decision making body according to the

PERSILAT constitution accept the recommendation of the 7th PERSILAT to review the current organization structure and regulation pertaining to PERSILAT and hereby decide to form the special committee consisting of 4 members nominated by the Founding Members plus 1 represents from Europe. We propose The Netherlands. I representative from Asia we suggest Vietnam, I representative from the Pacific we suggest Australia to report the findings of the Committee within 6 months to discuss for the constitution.

Secondly, according to PERSILAT constitution Article 10 paragraph 1.2. "The President shall be nominated by the Founding Members in the meeting of Founding Members and Congress of PERSILAT. The nominated shall then be discussed and resolved by the Founding Members and announce in the Plenary Meeting of PERSILAT Congress for 4 years.

The Founding Members hereby announce the anonymous consensus of the Founding Members to appoint Mr. Prabowo Subianto President of IPSI to be the next President of PERSILAT for the term 2010 to 2014 and to appoint Haji Eddie Marzuki Nalapraya of the Chairman of Dewan Sesepuh or Counsel of Elders of PERSILAT.

- PESISI, and,
- PERSIB.

That's all I want to announce to you.

#### Plenary session II B. Speech and Closing by the Newly Appointed President of PERSILAT



Chairman - New President of PERSILAT Mr. Prabowo Subianto: "First of all I would like to thanks to the member representative of the Congress and also the Founding Members that I have been given the appointment to be the next President of PERSILAT. We have discussed this at our within and we have decided that under the current constitution and we will carry out to review the organization and restructuring by special committee and we will convince special conference to discuss restructuring and review the PERSILAT organization. That was the decision of the Founding Members. I would like to use this opportunity to ask. We will accommodate any questions or comments."

The Netherlands/Europe: "Congratulated the appointment of Mr. Prabowo Subianto. Suggested Mr. Prabowo to be fast student to master the constitution. Suggested Pak Eddie to guide the remodeling of PERSILAT. Expecting not only announcing the new President but also how will you reform the PERSILAT

Chairman - New PESILAT President: "Founding Members accept your recommendation to restructure and reform PERSILAT. For that we form the Committee consisted of Founding Members plus representative from Europe (The Netherlands), Asia (Vietnam) and Pacific (Australia). We ask Vietnam to represent Asia because de facto that Vietnam is one of the strongest as world champion of pencak silat several times. The second question is to ask Pak Eddie to oversee and review and we have decided to appoint Pak Eddie to be the Chairman of the Counsel of the Elder that is Dewan Sesepuh a very senior and respected body in the traditional pencal silat the sesepuh is the master, the teacher, is the one who is guiding us, but he is not involve in day to day executive functions. So we will ask him as the part of restructuring of this committee. And the committee will be very flexible committee. If the representative would like to appoint a task force of experts, we are open to the discussion. So, this committee will be the deliberate committee but to carry out the study we could have a task force of experts which can be more members from different countries. We have accommodated both of your suggestions. We have discussed between us I offered to the founding members but Malaysia declined, Singapore decline wants to concentrate on their own program but they asked to be given the chance to form the Asian Federation which not been formed yet and also the Founding Members agreed to give the honor to Singapore to form Pencak Silat Federation. Brunei also decline and they asked me on behalf of IPSI and I consider it my honor my duty to promote pencak silat and therefore I accepted. And that was the decision of our Founding Members. And we will be opened for the reformation, the review of the constitution and that's why we give the task to committee for 6 months. And if committee for the 6 months recommend again to us, we will convince. We will looking for the constitution for special extra-ordinary congress. But it's not in the constitution. This will be the task of special committee and we will re-convince the special session of the 7th congress to amend the constitution. That is the most efficient and the most wise alternative thought otherwise we were thinking continuing this congress but it will take several hours or days to conclude. We have basically accepted all of your recommendation.

We will ask Pak Eddie to agree to be Chairman of Elder which now is empty and many of sesepuh is not active or have died. We give privilege and honor to Pak Eddie to form this council from member countries with recommendations from member of participants. That is what we are proposing to you.

Suriname: "We have discuss that the current constitution is in discretion. It is already announced that the decision has been made. All decision should be made according to rules and regulations who will be the running candidate. Travel so long spend so much money to take part for this persilat. That is why we rely on person who can lead this with charisma, management skills, peaceful heart and diplomatic politics. I do not know who is he. But now the decision has been made. We do hope the new president that already elected think also about condition of PERSILAT at Suriname and also in the world. As part of satisfaction it should be better if we know before hot it would be gone so we feel also as one big family that will be happy all the time that we have good inspiration. How it would be and how it should be in the future. "

Chairman - New PESILAT President: "Really I need to comment that during the proceeding of Founding Members. In the beginning I understood that Malaysia would put forth for candidate which their President. I asked Malaysia, but the President of Malaysian Federation PESAKA who was the running candidate but officially withdrew his candidature. We offered Singapore but declined. We offered Brunei but declined. Then they asked me. If I also declined then we do not have any decision. Under the present constitution we have to have decision then I accepted for the shake of PERSILAT. But I personally support the desire to modernize and to review the structure of the PERSILAT. But we have decided that for efficiency and reality we can not do this overnight. We need time and therefore special committee has been formed and we accept representative from all regions so we appoint 7 members representing various regions and this will have the deliberaty power and authority from Founding Members to carry out review of the structure. So we will delivery cooly quietly for the shake of pencak silat to the best interest of everybody.

Switzerland: "Is there any changes in the near future? And do you have already vision where do we go for the federations?"

Chairman - New PERSILAT President: "The plan or the path or the roadmap is very clear that we want to re-energize pencak silat and therefore the special committee will have very important task and as a new President of PERSILAT that would be my mission is to re-energize, modernize the structure for the promotion and popularization internationally in the world stage and for that we have benchmark where aiming is the world festival of pencak silat we have to be in the middle of 2011 and we are discussion with Malaysia and Brunei to host this world festival. The 4 of us has decided to go on a road show to lobby the President of Indonesia, PM of Malaysia, the Government of Singapore and the Government of Brunei to increase the real support and sponsorship of pencak silat. Therefore basically the road map is very clear. I do not think there will be a big changes except the changes that we want to gather by special committee. Basically the vision is we want to achieve higher performance of and better acceptance of pencak silat. Strategy will be of course countries at Central Asia, countries of Middle East. We have now breach head in Saudi Arabia, in Morocco, in Jordan. So maybe we can easily add 10 countries from the Middle East and of course Africa. And t hen we have to go to Latin America, Caribbean, North America, we have breach head in Suriname. I personally determine to this-I was concentrating in IPSI. And basically I was the one who raise the money and built Padepokan in Taman Mini 18 years ago. Of course now bit needs renovations. But by have Padepokan we have always support PERSILAT. Now of course we want to do better because in 1998 we got hit by the crisis and as you know sport pencak silat also means money. We are very enthusiastic. Malaysia has built the world biggest arena. We are very happy. Before we were the biggest. Now Malaysia has overtaken us. So, the vision coming forward basically is how to promote and to push pencak silat. That is my concern. That's why the Founding Members in trust in me and because all the others decline I accepted and I took the challenge I took the responsibility. I am very confident that we can do very good job to push pencak silat.

Azerbaijan: "We have 4 Founding Members making decision regarding the choosing of the President but I think it would be better if all countries participating in making the decision. But since the decision has been made but I would like you to know M. Eddie Nalapraya has done a lot for the development of pencak silat and the stand of pencak silat today is the result of his work. I can not take to other countries but my country very much respected for Mr. Eddie Nalapraya. I respect the decision which has been made very much. And therefore I would like to suggest that Mr. Eddie Nalapraya can be chosen as Honorable President. And the work for reformation of PERSILAT to we need to oversee. And this will be very profitable for the development of pencak silat."

Chairman - The New PERSILAT President: "The recommendation has been answered because we have appointed and we are asking Pak Eddie to accept that he will be the Chairman of the Councel of Elders, the Dewan Sesepuh and by that he will guide us and will be with us. I always acknowledge the tremendous and great dedication of Pak Eddie and we will continue to ask his guidance and one of my first action after forming the board which I will form together with founding members I will suggest to them that we have special position as special representative of PERSILAT as ambassador of PERSILAT and we will ask Pak Eddie Nalapraya to be in that position so that he will continue to work for PERSILAT to push and represent PERSILAT in the international world. I do not see any conflict between our ideas.

We want to be in the spirit of family we will acknowledge and accommodate any ideas, recommendations that are prevalence. The tradition of pencak silat actually we are non-political, we do not want to go by conventional politics we want to deliberate we want to do it in familiar. If there is anything we are willing to sit down and talk. But in our opinion after our deliberation we have accommodated most of the recommendations, opinions of the congress and we have decided that this is the road path to go forward that one we want to promote pencak silat, push it. Target ASEAN GAMES but also popularize it to make it the real sport that people can be proud of. We have very rich, we have so many schools and aliran that we have many things that we can offer to the future generation of the world."

Spain: "Congratulation because you are the President of global federation. For me that is important question because in Europe it is very difficult to understand how is possible that 4 founder countries decide about the future of thousands of students around the world. Because our constitution is like this. Only 1 personal opinion especially last 5-10 years I felt lock-out situation for the international federations. I would like to ask you or pledge with you about the internationalization of PERSILAT including internal restructure because Pak Eddie ask me 15 years ago to go out of sun because President of CIO Mr Samarand also Spanish. PERSILAT? Who is PERSILAT? Malaysia, Indonesia, Singapore, Brunei. No more? No more? This is only reflection. Good reflection. Because lot of people here ask about Olimpics. On Olimpics are 5 continents, 15 countries minimum per continent and 1 global sponsor with 100 million US\$. Normally that is not questions of perguruan or aliran but money. First of all money. Congratulation but I hope in a short time that we go worldwide international federations.

Chairman - New PERSILAT President: "I completely agree with you, 100%. As I said, I have never been involved with PERSILAT. I was not in the committee that form the constitution, I am just carrying out the constitution that has been given to us. I am the first one to agree to reform the constitution. Because even in the constitution I found some mistakes even in the language. Even in the PERSILAT PLEDGE I was the one who corrected. I asked to be corrected. As I was not a member of PESILAT Board, I was just representing IPSI. I am 100% agree with you and that is why we form special committee and whatever the special committee will recommend we will come that convince all the Founding Members. But also we will work very open with you but let us be very realistic. For instance, if we want to carrying out real democratic vision one man one vote one nation one vote then we have also consider certain realities. For instance one new member with only maybe 30 athletes they will decide the future of pencak silat where there have member countries with hundreds of thousands of members. This has to be discussed by the special committee of people who are given the mandate and also the wise man we have to go to the Elders from Malavaia Brumi, Philippines, Indentesia, Spain, as to sit down as the with more in give as here to go forward. We have to choose in this real one federation one onte at one violenced may be I country as a new member who has been only with on for2 or 3 years do they have the same right or do we have certain categories. This all must be discussed. So, I completely agree and fully suppose. In that that is what I have tried to do in Indonesia IPSI. We give the 10 historical pergunuans, they have I vote in the national congress even though some of them are nearly extinct. But there were the Sociado: of IPSI. At one time I was compose but at the end they show me that it only enrich pencak silat. So maybe we have to send to Thailand to some more Than Or to Brazil to learn Capuera. This is my thinking how to revitalize and to energize nemauk silut. So I fully support you, Sir. And we hope that you always continue to give us input and through special committee we hope we will create a new roadmap more clear what we have to do in the DOTE 4 YOURS.
